1. We refer to the abovementioned matter. We confirm that we act on behalf of AfriForum NPC (“our client”), as well as a number of their members who are residents of the farms listed above, as well as the residents in surrounding areas of these farms, that will be affected should the mining rights be granted.
2. Our client received a background information document (“BID”) prepared by Singo Consulting (Pty) Ltd inviting all interested and affected parties (“I&AP”) to participate in the process where Manzolwandle Investments (Pty) Ltd is applying for mining rights. The BID emphasises that the public involvement is an essential component of the environment process and requested that an application form be completed in order to keep all I&AP informed.
3. Our client, as well as several of their affected members in their personal capacity, completed this application form. Same was sent through the 24th of June 2019, before the closing date. A follow-up e-mail was sent the 2nd of July 2019. We attach the correspondence hereto as **Annexure “A”** for your ease of reference.
4. It is our client understanding that meetings have been held and documentation and/or information is ready, but to date our client has not had sight of any documents or notices despite being registered as an I&AP.
5. It is our clients view that not any of the necessary processes are being followed and I&AP are being kept in the dark. Our client is currently severely prejudiced, due to not having the relevant documentation at hand in order to meaningfully respond and/or make meaningful representations of what the intended mining impact will have on the environment. We hereby request that all relevant and/or necessary documents be forwarded to our offices within **5 (five) working days** after receipt hereof in order to enable our client to conduct its own investigations. Should the documents not be provided timeously, we will on this basis demand a further

extension to submit their representations.

6. Our client reserves the right to amend its submissions after the relevant information, including the documents requested herein, become available.
7. Since we are now on record all information and notices can be sent directly to our office.
8. We await your urgent reply herein.
